4) DCMC: Combining Districts Report

This is a follow up that the ECM Meeting asked Alex (DCMC) to present separately from this position being created.

Background – read by Jeff: <this comment is written in by Jeff from Minutes of our last ECM> District 3 is struggling during quarantine and is basically dark. For now, if the motion passes, Erin V, District 3 DCMC will be our District 3 Liaison, only.

DCMC: Reading – from the AA Service Manual:

Page S34; "Redistricting", explains various methods on how to manage a District's expansion, such as when the number of Groups or District Membership (i.e. size of a District) becomes difficult or too large to be effectively managed by the D.C.M.

a) Findings, report, and proposed combined district formation.
 Alex: attended the Westside Combined Districts Business meeting in Area 5.

Alex discussed: Presented a full report potentially going from representing 6 cities to 12 cities, screen sharing an example of a combined CM Agenda, with possible DCMs, committees, Treasurer's report and the benefits for combing Districts, how the meeting is to run and what it could look like for this formation to occur based on the West Side Combined Districts. (A full report is on a separate google doc and available upon request.)

b) District 3 Group Conscience on combining districts.

Erin: DCMC D3 - stated that they need help and she is the DCMC for the 5th year in a row. Their district is mainly made up of new people rotating and they are in full support of combing the district to increase participation and alleviate the pressure of having committees so they can focus on having GSRS and group participation.

Jeff: Is this Covid-19 related? Erin: Nothing is implied by District 3's plea for help that the current situation is temporary or in any way related exclusively to the coronavirus and that this lack of GSR involvement, turnover and 3rd-legacy spirit of rotation has been a systemic problem in District 3 going back for many years.

Scott: (for example) many so-called newcomers from various San Pedro recovery houses may show up to one GSR meeting, take a commitment, then fail to return, leaving the position vacant again and again.

Erin: feeling trapped – zero rotation

c) Comments from the body

Jim: Do not see how combining helps, perhaps leads to diluting. From Jeff and Jim: This reading <Service Manual Page S34> describes methods on redistricting in the context of District "expansion" and "splitting" or "dividing" a larger District into 2 or more, smaller Districts and/or subdistricts, etc. Although the instructions are enlightening, the reading is out of context from our situation. Our situation concerns combining a struggling District with and into a larger functional District.

Jim: Stated - We need input from Ed L, because this is an Area 9 (MSCA) issue.

Alex our DCMC stated - the Area (Delegate and Alt Delegate) tasked her with researching this information and seeing if this is an option both districts would like to explore. She stated that this is NOT an Area Issue and is to be decided at the district level and then to inform the Area on our proceedings. As the Area does not have any authority over the District at all. We can proceed and act autonomously as a district.

Jeff and Erin: 90% of District 3's Groups are in San Pedro.

Jeff: There is a mistake, incomplete or unclear listing of District 3 cities noted on the Area 9 (MSCA) webpage, http://msca09aa.org/districts/d_03.php which says Cities in District (include): Carson, Dominguez, Harbor City, Lomita, San Pedro, Wilmington

Jeff: <u>Dominguez</u> is not a city; it is a suburb that may contain Groups in South Carson or Compton. Actual suburb names are Dominguez Hills and Rancho Dominguez. <u>Harbor City</u> is incomplete, or to be specific it should include Harbor Gateway and other unincorporated LA County Strip areas.

d) Suggestions on how to proceed

- Jeff: I am responsible, but how can we give a hand-up and not a hand-out? Consult Traditions and Concepts e.g.: Tradition 1 says our Group Unity comes first and Tradition 4, each Group is autonomous.
- Karyn: we should be honored that they asked for our help, but we do not want to damage or limit our ability to carry the message to the AA Members and Groups within our District boundary lines.
- We need to bring the idea to the whole body of District 1
- We need to hear from the District 3 Registrar, such as what are all the Groups, how many, what cities?
- We need more time to discuss the circumstances
- We should get to wait and hear from our newly created service position, District 3 Liaison

Alex needs to make a hard stop and adjourn the meeting at 8:00 pm, she begins summarizing for us the following ECM Agenda items:

Hi all, to clarify and answer Alex's' question as to Men's Meetings and Women's Meetings being listed in the Guidelines and having a DCM, the Guidelines say in Article II B. (Sub-districts) that "

• There are seven geographical and two gender-based sub-districts in District1....". The geographical sub-districts are listed, e.g. Torrance, PV, et.al. but the gender-based Men's' and Women's' are not. It is understood through long established District practice that they are what the guidelines refer to, but if it is the will of the body, this can be clarified and listed expressly in the guidelines revision that is underway. Thank you for letting me be of service.
