I attended the virtual MSCA 09 FORO on July 12th, and the virtual District 1 Executive Committee meeting on July 23rd.

As a member of the Finance Committee and after collaboration with Committee Chair Charles A. I sent a copy of proposed revisions of the Finance Committee guidelines to Ken O. on July 18th with a request to include the proposal in his presentation to the Executive Committee. This was done IAW Article XI B. "Annual Review" of the District guidelines.

On July 29th I met with Charles A., FCC via Zoom for his audit of District finances IAW Finance Committee guidelines.

On August 10th I met with Charles A., Finance Committee Chair via Zoom to begin 2021 budget preparations IAW Finance Committee guidelines.

Our beginning checking account balance was \$1209.90. I deposited \$201.15 in contributions. We had \$17.17 in expenses. Our ending checking account balance was \$1393.88 Our savings account/prudent reserve beginning balance was \$1601.10. We earned \$.01 in interest. Our ending balance was \$1601.11. There is no change in the purple bag balance.

Contributions: Of \$201.15 in contributions, \$83.76 was through online contributions. Please encourage your groups to use the online contribution portal on our District website. Expenses: Bank fees were \$16. Squarespace fees were \$1.17. These are transaction fees for our online contributions.
