I attended the MSCA 09 ASC meeting on August 9th, the MSCA 09 special Board meeting on August 23rd, and the District 1 Executive Committee meeting on August 27th. I also chaired the District 1 Website Committee meeting on August 6th.

Our beginning checking account balance was \$1393.88. We had \$287.91 deposited into the account. We had \$121.16 in debits to the account. Our ending checking account balance was \$1544.63. Our savings account/prudent reserve beginning balance was \$1601.11. We earned \$.01 in interest. Our ending balance was \$1601.12. There is no change in the purple bag balance.
