Huge congrats and thank you to the members who put on "Finding your niche in AA" we were joined by 45 members nationwide for an amazing morning. If you do not have a service sponsor, we strongly encourage you to obtain one. If you are willing and able please use the raise hand feature. Our next ASC is this Sunday, next month will be a Servathon followed by an ASC. I strongly encourage you to join and join in on a committee. In our next email blast as well as this chat I will be sending a survey that the remote communities have asked individuals in area 9 to fill out. Please take a couple minutes to answer these questions so we may better serve you. The technology ad-hoc committee is still in need of any additional members, please consider joining us. The DCMC school committee has created several apps for the members of Area 9. The first is a GSR app found in English and Spanish, please feel free to download onto your phone. As the creator of the app I will be happy to be of service. Please check the previous email I sent out for the links or the chat now for the GSR app found in Spanish and English. For any members who would like to learn how to create an app, we will have a follow up workshop on Nov 4th. Please reach out to be included. We are in October, and the deadline to submit an Agenda item to GSO will be December 15th. As a reminder we will have 7 trustee positions that will be rotating, as well as the general service manager chair. The General service board drew an additional \$1.5 Million from the Prudent Reserve, details on this can be found in the letter I am entering into the chat now. For anyone not aware, this was to cover the cash flow requirements for the last quarter in 2020. Our prudent reserve will be \$13.1 million which reflects 7.8 months of operating expenses. In May AAWS drew \$3 million from the prudent reserve, due to the lack of contributions and literature sales from the fellowship. After refunding \$4 million dollars for the canceled 2020 International convention registrations we did receive \$972.000 as an advance from our insurance claim. Please reference the letter now in the chat and that will also be sent via email for any additional questions. We send out emails on the first and third Thursday of every month, If you are not receiving this email please let me know. I also send out text reminders, if you would like to be included please advise me as well. We need a new Registrar, DCMS and a member to chair the Guidelines Ad Hoc Committee. I want to thank you all for my sobriety, and for allowing me to serve this district. It is such an honor and privilege.
