"Safety Issue" - Rough Draft Motion

GSB to create a Safety in AA Quickstart in Three Parts:

- 1) Q&A for Traditions & Safety Decisions (3), e.g. When does meeting safety rise to the level of impacting AA as a whole? What reputational risks to AA are there given related outside issues and events? How does Tradition Three impact group decisions on whether to ban a member?
- 2) Provide examples (3) that illustrate a range of solutions within the bounds of AA Traditions, e.g. Coiled Snake Poster 13th Step = Sexual Predation. 13th Steppers are Predators. Stay Away.
- 3) What is a crime? Provide a list of illustrative examples. eg, sending pornographic images to others without consent.

Purpose

Provide quick, concise guidance on safety to meetings that may not have experienced members, leadership, and sponsorship.

Background

Pornographic photos were sent to members by a circuit speaker, who is the brother of a celebrity. He used his informal authority, power, and influence, and AA's governance structure, to prey on meetings with mostly newcomers. Consequences were delayed while the meeting debated what could and should be done. One member at those meetings shared about the divisive experience during a group study of Traditions at Hermosa Beach Surf 'n Sand Sunday night.

Surf 'n Sand Sunday night is the sponsor of this motion. The meeting will begin testing a new format to contribute to a culture of safety within AA. The meeting believes that AA's safety resources need to be more readily accessible to the most vulnerable members.

Jane W reports that Cindy never got a full group sponsorship commitment as implied in the above presentation. Veto G announces it WAS discussed and authorized by the Surf & Sand SS Group. Cindy is stepping aside, and in her absence tonight, the motion fails as presented, however as possible cosponsor(s), Doug and/or Jane may wish to reintroduce the Motion at our next ECM for possible reconsideration in the next year's (2022) GSC. 10) **New Business:** Contribution to GSO – Treasurer Jim B comments: "no" this is NOT an action in the works; there's not enough money at this time. 11) Continuation of Elections – (2) significant positions: Finance Chair Alex W comments – every odd year District Committee Meeting; she reads and screen shares Finance Chair minimum qualifications from the District 1 Guidelines.
