I attended the Area 9 Pre-Conference Workshop on April 11th and the District 1 Executive Committee meeting on April 22nd.

Our beginning checking account balance was \$2111.46. We had deposits totaling \$228.50. Expenses and fees totaled \$370.67. (This included, among other things, one returned item in the amount of \$90 and the corresponding \$12 bank fee.
