District 1s' beginning checking account balance on September 1, 2021 was \$1985.19. September deposits totaled \$963.50. The District 1 ending checking account balance was \$2204.47.

District 1s' PayPal account beginning balance for July was \$784.02. Deposits totaled \$149.35. PayPal fees totaled \$11.87. The ending PayPal account balance was \$221.50. As previously mentioned, I transferred \$700 from PayPal to the District 1 bank checking account.

Therefore, total District 1 funds available on September 30th was \$4125.22.
